Participant Agreement, Release and Acknowledgement of Risk

This Participant Agreement, Waiver, Release, and Acknowledgment of Risk applies to the 2026 Lake Fork Lure Co. Tournament Presented by Sealy Outdoors. All contestants are required to read and sign this agreement prior to participating in the Lake Fork Lure Co. Tournament Presented by Sealy Outdoors.

I acknowledge that I have read, understand, and agree to comply with all tournament rules and regulations. I further affirm that I have voluntarily completed and signed the Official Entry Form and submitted the required entry fee to participate in the Lake Fork Lure Co. Tournament Presented by Sealy Outdoors.

Release and Waiver of Liability - In consideration of being permitted to participate, I hereby waive, release, and hold harmless all other contestants; Lake Fork Bait & Tackle, LLC, all sponsors and their agents; Sealy Outdoors, Inc.; and all tournament officials, including but not limited to their respective employees, officers, directors, managers, members, insurers, and representatives (collectively referred to as the "Releasees"), from any and all claims, including but not limited to personal injury, accidents, death, or loss, damage, or theft of property arising out of or related to participation in the tournament.

Insurance and Responsibility - I understand that boat insurance and liability insurance are my sole responsibility. I affirm that I have adequate health, accident, and liability insurance to cover any injury or damage resulting from my participation. If I do not carry such insurance, I accept full responsibility for any related expenses or liabilities.

Media Release - By providing my email address, I agree to receive communications from Lake Fork Bait & Tackle, LLC and Sealy Outdoors, Inc. I grant permission to Lake Fork Bait & Tackle, LLC, and Sealy Outdoors, Inc., Official Radio Station, Wood County, sponsors, and their agents to photograph, videotape, record, and/or broadcast my name, likeness, image, voice, and participation in the tournament for promotional or commercial purposes, without compensation or royalties.

Polygraph and Prizes - If I place for any prize, I agree to submit to a polygraph examination, and I acknowledge that the results shall be final and binding.
