**Release and Waiver of Liability** - In consideration of being permitted to participate, I hereby waive, release, and hold harmless all other contestants; St. Jude Children's Research Hospital; McDonald's® Corporation; Valluzzo Companies, LLC; the cities of Guntersville, Scottsboro, Albertville, and Boaz, Alabama; all sponsors and their agents; Sealy Outdoors, Inc.; and all tournament officials, including but not limited to their respective employees, officers, directors, managers, members, insurers, and representatives (collectively referred to as the "Releasees"), from any and all claims, including but not limited to personal injury, accidents, death, or loss, damage, or theft of property arising out of or related to participation in the tournament(s).
